Haj Mahmood J. Al Bunnia & Sons (HMBS)

Since 1910



The company emerged during the Ottoman Empire in 1910 by the trading business of Haj Mahmood Jassim Al Bunnia.

Haj Mahmood Al Bunnia first started by bartering goods and quickly became the main exporter of seeds, dates, beans, fruits, wool, and other commodities to several countries in the Middle East.

In the 1950s in order to meet market conditions and with the formation of the H. Mahmood J. Al Bunnia & Sons Company (HMBS), the operations expanded into the manufacturing of food stuffs and expanded trade to Europe and the United States. In the following decades as the socioeconomic environment became more dynamic, HMBS responded by vertically expanding its business lines to maintain independence and control to best serve its customers. Whenever HMBS faced a challenge or roadblock, the company looked within to overcome and succeed. This often required establishing new companies and competencies such as transportation. engineering, construction and other disciplines which quickly developed into significant enterprises within the HMBS portfolio. This intense goal-oriented focus remains a central part of the company's fabric and serves as the main drive for HMBS' vertical and horizontal integration.

In the almost 100 years since the company was founded, HMBS has remained a family business that has gained, held, and strengthened market leadership positions through the family strategy of managing its business with a long-term, regional perspective.




Background & Philosophy

Al Bunnia owns and operates numerous plants for the manufacturing of tomato paste and tomato juice as well as table sauces, dressings, halawa, tahania, pickles, dates, and natural date vinegars.

Al Mansour Production manufactures refined re-crystallized table salt, as well as industrial and animal salt blocks. The plant's production capacity is 250 tonnes per day.





Meat:

Al Bunnia Group meat processing companies utilize facilities to produce frozen foods such as red and white meat processed products (including fish) using the latest automated machinery technology. Additionally, a modern automated poultry slaughterhouse operates with two stork lines at a capacity of 6000 birds per hour for each line in addition to 10 large storage freezing rooms, each with a capacity of 500MT.











Al Bunnia Group also owns and operates a number of modern automated butcheries and a modern automated poultry farm. The farm provides eggs for the hatchery and birds for the meat processing plant.

The Poultry farm is composed of more than 25 poultry houses, each house containing more than 22.000 birds on average. In addition to Al Bunnia Group own poultry houses, the slaughter house contracts with other farmers to supply the birds.

Lastly, Al Bunnia Group also owns and operates a plant for the production of protein concentrate used in the manufacture of various types of animal feed. Al Bunnia Group animal feed facility manufactures feed for poultry, cattle, horses, sheep and fish with an average output of 25 tonnes per hour.






In facilities throughout Iraq, Eastern Frozen Foods and Howlair Dairy & Refreshments manufacture various ice creams, and iced Iollies. These companies also manufacture European-quality yogurt, cheese and cream as well as natural fruit juice drinks (under license from Rauch, Austria). Both companies utilize a container production plant for the long-life packaging of products.

Additionally, United Farm Livestock owns and operates large farms with approximately 6.500 heads of prime Arizona Holstein milking cows in addition to large herds of sheep, water buffalo, and cattle. Recently a study was completed with the intent of doubling the number of livestock to meet the growing demand of the Iraqi market. The farm also contains over 20.000 hectares of farm land for wheat, barley, maize and alfalfa crops as well as lands for animal grazing and feeding.

The farms' output of fresh milk and meat is used by other Al Bunnia Group's sister companies in their production.












